

TOWN OF OAK ISLAND TAX NOTICE

If you have sold this real property assessed to you, please forward the "Tax Statement" to the new owner. Delinquent taxes are advertised in the name of the record owner on the date the property tax became delinquent.

DUE DATE: Property taxes are due and payable upon receipt and delinquent if not paid by January 5, 2025

In accordance with the local legislation passed by the N.C. General Assembly in 2009, the Town of Oak Island established a Sewer Treatment District to include all properties that benefi (or could potentially benefit) from the availability of sewerage treatment. The Town charges a Sewer District Fee (SDF) to all parcles within the district to pay the annual debt service on the system. The Town Council evaluates this fee and takes action to set the amount prior to July 1 each year. As defined in the enabling legislation, fee is collected in the same manner as ad valorem taxes.

The tax bill displays a summarized version of all credits made to the account prior to billing.
